David most recently served as Deputy Executive Director and General Counsel of the National Rifle Association’s Institute for Legislative Action (ILA) from 2002 to late 2019. In that capacity, David was one of the NRA’s principal political, policy and legal strategists. As ILA’s General Counsel, David led all of its efforts in the legal arena, overseeing a team of inside and outside counsel and achieving numerous victories in federal and state courts across the country. Perhaps most notably, he was responsible for the organization’s role in the landmark U.S. Supreme Court decisions in *District of Columbia v. Heller* and *McDonald v. City of Chicago*, in which the Court held that the Second Amendment to the U.S. Constitution guarantees the fundamental, individual right to keep and bear arms for self-defense.

In the political arena, David helped lead ILA’s election efforts in every cycle since 2002, overseeing direct mail, grassroots, digital, television and radio advertising. He was responsible for all aspects of ILA’s political campaigns, including creative message development, advertising production and placement, grassroots targeting and ILA’s extensive direct mail outreach.

Legislatively, David was instrumental in successfully enacting laws to protect self-defense and Second Amendment rights across the country. Among these was the Protection of Lawful Commerce in Arms Act, which protected U.S. firearms manufacturers from being driven into bankruptcy through frivolous lawsuits.

Through this experience, David developed a strong expertise in strategic communications and crisis management, as well as the ability to successfully design, develop and execute winning political and grassroots campaigns. Before joining NRA, David was a consultant with Hall, Green, Rupli and the Federalist Group, advising clients on a variety of intellectual property and telecommunications issues. From 1994 to 2001, he worked in the U.S. Congress, serving as Legal Counsel for Reps. Jimmy Duncan (R-Tenn.) and Lamar Smith (R-Texas), as well as Chief of Staff for Rep. Bob Goodlatte (R-Va.).
